## **Code of Conduct for Employees in Schools**

## Objective, Scope and Principles

This Code of Conduct is designed to give clear guidance on the standards of behaviour all school employees are expected to observe. School employees are role models and are in a unique position of influence and trust and must adhere to behaviour that sets a good example to all the children within the school. As a member of a school community, each employee has an individual responsibility to maintain their reputation and the reputation of the school, whether inside or outside working hours.

This Code of Conduct applies to all employees of the school. This Code of Conduct does not form part of any employees' contract of employment.

In addition to this Code of Conduct, all employees engaged to work under Teachers' Terms and Conditions of Employment have a statutory obligation to adhere to the '*Teachers' Standards 2011, updated 2013*' and in relation to this policy, Part 2 of the Teachers' Standards - Personal and Professional Conduct.

A teacher is expected to demonstrate consistently high standards of personal and professional conduct. The following statements define the behaviour and attitudes which set the required standard for conduct throughout a teacher's career.<sup>1</sup>

- Teachers uphold public trust in the profession and maintain high standards of ethics and behaviour, within and outside school, by:
  - treating children with dignity, building relationships rooted in mutual respect, and at all times observing proper boundaries appropriate to a teacher's professional position
  - having regard for the need to safeguard children's well-being, in accordance with statutory provisions
  - showing tolerance of and respect for the rights of others
  - not undermining fundamental British values, including democracy, the rule of law, individual liberty and mutual respect, and tolerance of those with different faiths and beliefs
  - ensuring that personal beliefs are not expressed in ways which exploit a child's vulnerability or might lead them to break the law.
  
- Teachers must have proper and professional regard for the ethos, policies and practices of the school in which they teach, and maintain high standards in their own attendance and punctuality.
  
- Teachers must have an understanding of, and always act within, the statutory frameworks which set out their professional duties and responsibilities.

<b>PREAMBLE</b>	
Teachers make the education of their pupils their first concern, and are accountable for achieving the highest possible standards in work and conduct. Teachers act with honesty and integrity; have strong subject knowledge, keep their knowledge and skills as teachers up-to-date and are self-critical; forge positive professional relationships; and work with parents in the best interests of their pupils.

<b>5 Adapt teaching to respond to the strengths and needs of all pupils</b>

In addition to teachers having an understanding of Teachers Standards, it is advised that all staff have read and are aware of the '*Guidance for safer working practice for those working with children and young people in education settings, October 2015*'.<sup>3</sup>

## **1. Setting an Example**

1.1 All staff who work in schools set examples of behaviour and conduct which can be copied by children. Staff must therefore for example avoid using inappropriate or offensive language at all times.

1.2 All staff must, therefore, demonstrate high standards of conduct in order to encourage our children to do the same.

1.3 All staff must also avoid putting themselves at risk of allegations of abusive or unprofessional conduct.

1.4 This Code helps all staff to understand what behaviour is and is not acceptable, regard should also be given to the disciplinary rules set out in the school's Disciplinary Procedure.

1.5 All staff are expected to familiarise themselves and comply with all school policies and procedures.

## **2. Safeguarding Children**

2.1 All staff have a duty to safeguard children from physical abuse, sexual abuse, emotional abuse and neglect. This also includes staff having an awareness of Female Genital Mutilation, Child Sexual Exploitation, Prevent Agenda and Child missing from education as per Keeping Children Safe in Education September 2021.

2.2 The duty to safeguard children includes the duty to report concerns about a child or colleague to the school's Designated Safeguarding Lead for Child Protection & Safeguarding.

2.3 All staff have a duty to know the names of the DSL's in school.

2.4 All staff are provided with personal copies of the school's Child Protection Policy and Whistleblowing Procedure and staff must be familiar with these documents. These documents are provided electronically to staff who have a school email address.

2.5 All staff should treat children with respect and dignity and must not seriously demean or undermine children, their parents or carers, or colleagues.

2.6 All staff should not demonstrate behaviours that may be perceived as sarcasm, making jokes at the expense of students, embarrassing or humiliating students, discriminating against or favouring students.

2.7 All staff must take reasonable care of children under their supervision with the aim of ensuring their safety and welfare.

2.8 All staff have read and understood Part 1 of Keeping Children Safe in Education September 2021.

2.9 All staff have a duty to disclose any wrongdoing or alleged wrongdoing, including any incidents arising from alternative employment or outside of work which may have a bearing on their employment with the school. This would include, but is not limited to, police arrests and cautions and investigations by the Local Authority Designated Officer for Safeguarding (LADO).

### **3. Relationships with children**

3.1 All staff must declare any relationships that they may have with children outside of school; this may include mutual membership of social groups, tutoring, or family connections. Staff should not assume that the school are aware of any such connections. Staff must declare this relationship by email to the Head Teacher.

3.2 Relationships with children must be professional at all times, physical relationships with children are not permitted and may lead to a criminal conviction.

3.3 Contact with children must be via school authorised mechanisms. At no time should personal telephone numbers, email addresses or communication routes via personal accounts on social media platforms be used to communicate with children.

3.4 If contacted by a child by an inappropriate route, staff should report the contact to the Head Teacher immediately.

### **4. Child Development**

4.1 All staff must comply with school policies and procedures that support the well-being and development of children.

4.2 All staff must co-operate and collaborate with colleagues and with external agencies where necessary to support the development of children.

4.3 All staff must follow reasonable instructions that support the development of children.

### **5. Honesty and Integrity**

5.1 All staff must maintain high standards of honesty and integrity in their work. This includes the handling and claiming of money and the use of school property and facilities.

5.2 All staff must comply with the Bribery Act 2010. A person may be guilty of an offence of bribery under this act if they offer, promise or give financial advantage or other advantage to someone; or if they request, agree or accept, or receive a bribe from another person. If you believe that a person has failed to comply with the Bribery Act, you should refer to the Whistleblowing procedure for schools.

5.3 Gifts from suppliers or associates of the school must be declared to the Headteacher, with the exception of "one off" token gifts from students or parents. Personal gifts from individual members of staff to children are inappropriate and could be misinterpreted and may lead to disciplinary action.

5.4 Gifts from individual staff members to children should only be part of the schools rewards system and clearly outlined in school's policy.

### **6. Conduct outside of Work**

6.1 Staff must not engage in conduct outside work which could seriously damage the reputation and standing of the school or the employee's own reputation or the reputation of other members of the school community.

6.2 In particular, criminal offences that involve violence or possession or use of illegal drugs or sexual misconduct are likely to be regarded as unacceptable.

6.3 Staff may undertake work outside school, either paid or voluntary, provided that it does not conflict with the interests of the school nor be to a level which may contravene the working time regulations or affect an individual's work performance in the school.

6.4 Staff are reminded of their expectation to inform school where their relationships and associations, both within and outside of the workplace (including online), may have implications for the safeguarding of children in school.

## **7. E-Safety and Internet Use**

7.1 All staff must exercise caution when using information technology and be aware of the risks to themselves and others. Regard should be given to the schools' E-Safety and ICT Acceptable Use Policy at all times both inside and outside of work.

7.2 Staff must not engage in inappropriate use of social network sites which may bring themselves, the school, school community or employer into disrepute. Staff should ensure that they adopt suitably high security settings on any personal profiles they may have.

7.3 Staff should exercise caution in their use of all social media or any other web based presence that they may have, including written content, videos or photographs, and views expressed either directly or by 'liking' certain pages or posts established by others.

7.4 Contact with children should only be made via the use of school email accounts or telephone equipment when appropriate.

7.5 Photographs/stills or video footage of students should only be taken using school equipment, for purposes authorised by the school. Any such use should always be transparent and only occur where parental consent has been given. The resultant files from such recording or taking of photographs must be stored in accordance with the schools procedures on school equipment.

## **8. Confidentiality**

8.1 Where staff have access to confidential information about children or their parents or carers, staff must not reveal such information except to those colleagues who have a professional role in relation to the child.

8.2 All staff are likely at some point to witness actions which need to be confidential. For example, where a child is bullied by another child (or by a member of staff), this needs to be reported and dealt with in accordance with the appropriate school procedure. It must not be discussed outside the school, including with the child's parent or carer, nor with colleagues in the school except with a senior member of staff with the appropriate authority to deal with the matter.

8.3 However, staff have an obligation to share with their manager or the school's Designated Safeguarding Lead any information which gives rise to concern about the safety or welfare of a child. Staff must **never** promise a child that they will not act on information that they are told by the child. Staff should never promise a child confidentiality or 'keep a secret'.

## **9. Dress and Appearance**

9.1 All staff must dress in a manner that is appropriate to a professional role and promoting a professional image.

9.2 All staff should dress in a manner that is not offensive, revealing or sexually provocative.

9.3 All staff should dress in a manner that is absent from political or other contentious slogans.

## **10. Disciplinary Action**

All staff should be aware that a failure to comply with the following Code of Conduct could result in disciplinary action including but not limited to dismissal.

## **11. Compliance**

All staff must complete the form in Appendix 1 to confirm they have read, understood and agreed to comply with the code of conduct. This form should then be signed, dated and then passed on to the Head Teacher.

### **Professional Responsibilities**

When using any form of ICT, including the Internet, in school and outside school

#### **For your own protection, the school advises that you:**

- Ensure all electronic communication with students, parents, carers, staff and others is compatible with your professional role and in line with school policies
- Do not talk about your professional role in any capacity when using social media such as Facebook, Twitter, Instagram and You Tube, et cetera
- Do not put online any text, image, sound or video that could upset or offend any member of the whole school community or be incompatible with your professional role
- Use school ICT systems and resources for all school business. This includes your school email address, school mobile phone and school iPad/ Laptop etc.
- Do not disclose any passwords and ensure that personal data (such as data held on CPOMS) is kept secure and used appropriately
- Only take images of students and/or staff for professional purposes, in accordance with school policy and with the knowledge of SLT
- Do not browse, download, upload or distribute any material that could be considered offensive, illegal or discriminatory
- Ensure that your online activity, both in school and outside school, will not bring the school or professional role into disrepute
- Your school e mails should be checked daily, as a minimum on working days or every other day if one day is particularly busy
- You have a duty to report any E Safety incident which may impact on you, your professionalism or the school to your DSL or SLT
